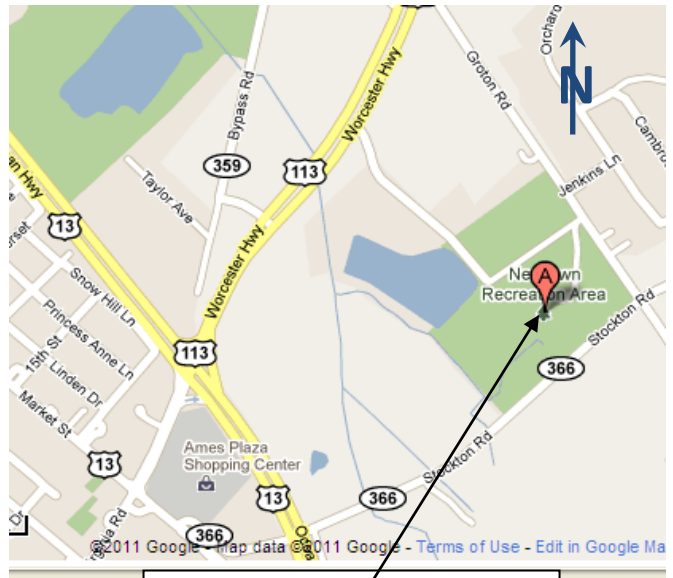


# 2011 Pocomoke Warrior Bike Ride Registration
